HOA Board Meeting vs. Member Meeting

As noted under Upcoming Meetings, there is a **HOA Board Meeting** and a **HOA Members Meeting**. In case you were asking yourself, 'why two meetings', and 'do I need to attend both', here is a brief explanation of the two different meetings.

A **HOA Board Meeting** is a meeting of the **Board** to discuss daily operations of the HOA, which include committee reports from ARC, Communications, Finance, Landscaping, Maintenance, Safety, and ad-hoc committee reports from the Lake Bank Restoration and Office Building Utilization. The Manager's Report will include various topics including, but not limited to, rules violations, budget, ongoing/regular maintenance, and Local, County, and State Motions and Bills.

It is at these meetings that a quorum of **Board** members is required if there is a vote needed on a topic relating to the general operation of the HOA. **Board** meeting attendance is open to all Members. Members have the right to speak on any agenda items when they are invited to do so. Topics not on the agenda will be considered for another meeting.

The other meeting being held in March is a **Member** Meeting. These meetings are unscheduled meetings that are called to handle a specific issue. In this case, the **Member** meeting was called so **Members** can vote to adopt the updated governing documents, Articles of Incorporation, Covenants, Conditions and Restrictions (CC&Rs), and the Bylaws.

^{*}Internal move

A quorum of **Members** must be present, in person or by proxy, at the meeting, in order for the business to be conducted. A proxy is for the purpose of appointing another person to vote for you in the event you might not be able to attend the meeting. It must be signed by all owners of the dwelling. Florida law does permit the use of facsimile or electronic transmission for proxies.

New TwinEagles HOA Community Website Launch

Your HOA Board of Directors have been working diligently with the FirstService Residential Property Management Team to launch a new and improved website experience, which is due to go live on March 12th! Shortly, you will receive an email inviting you to register on the new site. The new website will be a valuable tool that makes it very easy to stay connected to your community anytime and from anywhere. With just a few clicks, you can communicate with your community manager, board members, and neighborhood property managers. You will also be able to access forms, such as the Architectural Review Form, and access documents, including past newsletters, Board and Committee Meeting minutes, Service Requests (HOA common areas), and Rules and Regulations. There will also be a general FAQ section, as well as quick links to the most often requested information. For example, the new website will have a quick link to the Lake Bank Restoration information. You will also be able to view your assessment amounts, pay your assessment fees (via quick link to FSR portal and Click-Pay), and so much more!

TwinEagles HOA Responsibilities

As a reminder, in addition to maintaining the assets of TwinEagles, the TwinEagles HOA is responsible for various functions that protect the aesthetic appeal and value of our community. Our property manager, FirstService Residential, works directly with TwinEagles HOA board representatives, committees and vendors to provide the following functions:

- Engineering Committee Repair and Maintenance of roads, sidewalks, lighting, fountains.
- Safety Committee Implementation of security equipment, procedures and resident training of the gate access system. Development and implementation of all safety guidelines regarding pedestrian, bicycle, auto and golf cart traffic.
- Landscaping Committee Ongoing monitoring, repair and replacement of landscaping and irrigation systems along roadways.
- Architectural Review Committee Approval of changes to all exterior home and landscaping.
 Enforcement of community approved standards. Enforcement of exterior maintenance standards for *single family homes* including: driveways, mailboxes, tile roofs and lanais.
- Finance Committee Fiscal management of the Master HOA, vendor contract review and monitoring, preparation of operating and capital budgets, monitoring banking and investment holdings.
- Preparation of estoppel letters for home resale.

A Compliance task force is used only when necessary to sets fines for violations of community rules

Important Rules of the Road

There have been several recent near-miss road incidents that were a result of unsafe driving maneuvers and could have resulted in very negative outcomes. We ask that all residents read and follow these important reminders to keep everyone in the community safe from harm:

- Stay in the correct lane, unless it is clear to pass.
- Don't text and drive.
- Don't drive under the influence and don't let relatives drive under the influence!
- **Bicyclists** are expected to ride on the sidewalks along TwinEagles Blvd (TEB). Ride on TEB only when necessary and yield to all vehicles by pulling over as soon as practical. Use hand signals to indicate turns. Ride single file, and obey all traffic signs and laws.

- Resident golf cart operators are expected to only carry passengers that have seating. DRIVERS MUST BE
 16 YEARS OR OLDER! Drive only on residential streets, and NO DRIVING ON SIDEWALKS except on the
 widened areas of TEB. Yield to bicyclists and pedestrians when sharing these sidewalks. Use Bald Eagle
 Way and Talon Drive rather than TEB. Ride as far right as possible in the direction of traffic flow on the
 streets.
- Golf cart operators MUST abide by ALL stop signs along TwinEagles Blvd!

Audubon Committee Information

February 15th, 2024

Dear TwinEagles member,

The Talon Natural Resources Management Plan (NRMP) Chapters 1-13 are back for final changes to be completed by TE. Kat has sent the Eagle NRMP back for final audit. All changes will be addressed and resent back to Audubon for final approval.

Both courses have been seeing more favorable growing conditions. The El Niño is still on-going but weakening for greater intervals of conducive turfgrass growth. However, there have been some more negative effects on our aquatic plants. They are suffering from the cold wet winter and hot dry summer, which caused the lake levels to become unbalanced. Too low and too high levels have caused thinning and death to some species. Affected species are spike rush, arrowhead, alligator flag and pickerel weed. Also, milkweed has struggled all winter long, especially devastating to the survival of the Monarch Butterfly.

On the positive side, we are seeing the first fawns and baby alligators. Hopefully it will be an early spring. We are expecting a heavy pollen drop on both courses, but #1 Eagle lake is affected more than others. The pollen is yellow in color and is most visible around the edges of the lakes. Another sign of the changing season is the leaf drop of our deciduous trees. On the Eagle #6, the butterfly garden has been reseeded with wild flowers. The bathroom on #4 Talon has been landscaped.

Brian from Native Bird Boxes stopped by the property first week of February to prepare us for the Fall months. Many of the units are still "roosting by others", in preparation for Fall. We will start seeing all the common dwellers return soon. Paul Shannon from Strictly Beesness has also been busy on property observing and collecting honey from our beehives, which have been extremely abundant with activity. The bee boxes at golf maintenance continue to produce honey. The honey has been so good that even our Bears have been busy knocking our electric fence out to get their fair share.

Alert Collier

Did you know that Collier County has a mass emergency notification system called "Alert Collier"? When you sign up with Alert Collier you can enter up to five addresses within the County boundaries for which you would like to receive emergency alerts. Enter your home, work, relative, school or any other address that's important to you.

Southwest Florida Wildlife

Southwest Florida, and TwinEagles in particular, is home to so much interesting and beautiful wildlife. Although many of us have seen deer, bunnies, and other animals in other locations of the country, there are many animals that some of us have never seen up close and personal until we moved to TwinEagles. We thought it would be interesting to learn about some of these animals that live in Florida. Each month we will highlight a different animal.

This month we choose the Flamingo. While flamingos were originally native to Florida, most of the flamingo



population disappeared from Florida at the start of the 20th century due to habitat destruction and humans over-collecting their eggs and feathers. Captive flamingo colonies were created by people in the southern part of Florida in the mid-1920s. One of the first colonies was in Hialeah, Florida. Several flamingos also arrived independently from elsewhere in the Caribbean. Although flamingos aren't usually migratory, they will move if conditions change, such as rising water levels or dwindling food supply. Although flamingos are considered by most to be a staple of Florida, Florida's flamingo population actually only

represents about 1 percent of the current global species' population! The majority of flamingo sightings in Florida have happened in the Everglades, nearby Biscayne Bay, and the Florida Keys. They are most easily viewed in the spring through summer due to the more favorable weather of these seasons.

There are six different species of flamingo, but they are not easily distinguishable by most people. The adults are about four to five feet tall, but only weigh between four and eight pounds. They tend to congregate in mudflats or lagoons, where they can find shallow saltwater prey. It is also hard for predators to negotiate these habitats. Their pink coloring comes from beta-carotene in the crustaceans and plankton that they eat. If flamingos who live in the zoos do not eat live shrimp or other food containing carotenoid pigments, they will turn white.

Flamingos flock in large groups of up to several hundred birds. The male and female of a mating pair build a nest together, and both sit on the egg while it incubates, which takes about a month. The nest must be carefully guarded, as other flamingos may try to steal a nest that's already been built. Both parents take turns feeding the flamingo chicks. Their food consists first of a special liquid baby food that they produce in their throats, called crop milk, then regurgitated regular flamingo food as the chick ages. The feathers of the chicks are originally grey and white, and then turn pink after a year or two. Their beaks are initially straight, and begin to curve as they grow.
